- Commissioner Steve Garchar, Chair, called the meeting to order at 2:34pm.
- The agenda was reviewed.
- A quorum was established.
- SWORD members were introduced.

I. Feasibility Study

Health Management Associates (HMA) presented the final findings and recommendations of the feasibility study. Abbreviations SUD and OUD are used throughout the minutes for substance use disorder and opioid use disorder. Feedback from SWORD members since the June meeting as well as additional expertise leveraged by HMA was incorporated into the final report. The presentation covered five main topics including:

- The methodological overview
- Description of Region 9 priority SUD treatment services
- Feasibility of SUD/OUD services
- Recommendations, and findings from the assessment.

The research questions HMA was asked to explore in this study were:

- What is the need or demand for SUD treatment and recovery services, including inpatient treatment in Region 9?
- What specific services exist and where do service gaps exist?
- What are initial estimates of feasibility per the above, including cost estimates to build, operate, address equity, and contract?
- What are initial funding recommendations and source mix?

HMA presented the following assessment findings in their presentation:

- Overview of the Identified Needs and Gaps in Southwest Colorado
 - Community Context and Population Demographics
 - OUD and SUD Needs Assessment and Document Review
- Gap Analysis of SUD/OUD Services
- Region 9 Community Priorities
- Existing and Future Service Demands
- Recommendations for Strengthening Region 9's SUD/OUD Prevention, Treatment and Recovery
- Feasibility of Building SUD/OUD services identified as Gaps
 - Service #1: Residential/Inpatient Facilities
 - Service #2: Crisis Stabilization Facility
 - Service #3: Methadone Clinic

SWORD members offered comments regarding potential funding scenarios using the DeNier Center in the study and it was acknowledged that scenarios presented do not indicate foregone decisions about use of the DeNier Center or any other assets used in the scenarios.

Information was provided about SWORD's structure and committees as the council moves from planning to implementation, including potential staffing opportunities for project coordination once SWORD prioritizes funding areas.

II. Votes:

- 1. Approve the Substance Use Treatment Feasibility Study and Implementation Plan as presented today by HMA with acknowledgment that the findings and recommendations do not imply SWORD's conclusions about future actions or funding decisions, rather, as a starting point for informing future actions and funding decisions by SWORD and permission for HMA to move forward with the final written report.
 - i. Chair, Commissioner Garchar asked for a motion. Martha Johson motion. Erin Hyder second. **Motion passed.**
- 2. Approve support for Region 9 EDD to move forward with two separate applications for capacity building roles to assist SWORD with project coordination for SWORD priorities.
 - Chair, Commissioner Garchar asked for a motion. Commissioner Ronnie Maez motion.
 Commissioner Marsha Porter Norton second. Motion passed.
- 3. Approve the use of the proposed organizational chart as a guide for SWORD as the need for structured committees arise.
 - Chair, Commissioner Garchar asked for a motion. Erin Hyder motion. Jessica Thurman second.
 Motion passed.

III. SWORD Member Resignations:

- Voting member and SWORD's Vice Chair Andrea Phillips announced her resignation from SWORD effective August 4th to coincide with her last day serving as Town Manager for Pagosa Springs.
